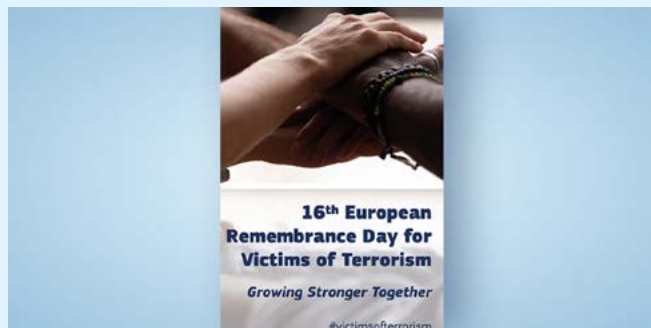
RAN

RESPONDING TO TERROR ATTACKS

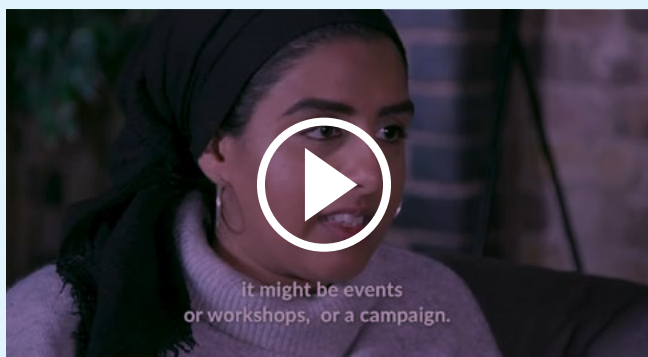
